Credential Files

Discussion regarding usefulness and cost effectiveness of credential files. General consensus is that schools will gradually get out of the credential business by encouraging students to handle their own credentials. Surveys have shown that most school districts do not care who sends the letters of recommendations any longer. School Districts need to verify all credentials anyway.

Teacher Fairs

Schools participating in Teacher Fairs met to discuss the mailing for the 1996 Teacher Fairs. Lynne Boyle presented what had been done and asked for okay to **increase budget for mailing** which was **approved** by participating schools.
