HB1037 – increases personal vehicle mileage from \$.20/mi. to \$.28/mi. in 1999.

Enterprise vs. scholarship

Differences in philosophy, goals, programs, etc.

Accreditation requirements and different accreditation authorities Majority of students need to be enrolled in degree granting programs Concern over one person/institution changing the nature of the current association

Duties of career development personnel as opposed to placement only activities

Appropriateness of institutional mission statements
