"Providing Career Services to International Students"

Presented by Jack Brewer of the University of Southern Colorado and Joanne Wambeke of CU-Denver

- § The presentation discussed the importance of the career services office working collaboratively with the international student office to provide career services to international students. Reviewed issues and concerns of both offices to help determine "whose job is it to do what?" Workshop ideas were presented by CU-Denver called "American Job Search for International Students." - I. Legislative updates-Rich Baca, Mesa State
- § The state has an annual budget of 5 billion, 300 million. Of that number, 734 million is spent on education. The Tabor law states that there will be a 6% increase to the budget each year.
- § Governor Owens priorities include, Transportation-175% increase in budget, k-12 education-7% increase in budget, corrections-10% increase in budget, higher education-2.5% increase in budget.
- § The Barry Bill, introduced 1 ½ years ago is looking at the re-organization of higher education in the state. This may affect the State College System of which Adams State, Mesa State, and the Metropolitan State College of Denver are members. Thus, the next legislative session will be very important to the future of higher education. K-12 education can be a predictor of higher education assessments and new initiatives. UNC is a good example of how things are getting politicized.
