# **Professional Development Presentations:**

"Engaging the Millennials in Career Services" by Julie Elliott and "The Future of Career Services" by Lissa Gallahger and Lisa Severy. The presentation, "Engaging the Millennials in Career Services" discussed the research findings presented by N. Howe and W. Strauss in their two books

"Millennials Rising" and "Millennials Go To College." The breakout sessions during this presentation were to get feedback from the different CCSA groups as to if they were seeing the same kinds of trends in the students they are serving or different ones. "The Future of Career Services" discussed the changing education and employment environments and what are some of the ways we can begin to address these changes.

### **Old Business:**

#### **CCSA 2006 Spring Conference Location:**

- It was decided at a prior meeting to go back to the two-day Spring Conference format. Given that decision, the Spring 2006 CCSA Conference dates will be May 18 & 19.
- Lisa had researched Keystone, Steamboat Springs and Glenwood Springs as three possible locations for the Spring Conference. During the discussion, members expressed several concerns about the Steamboat Springs site including the long distance from Durango and Denver. The high altitude of Keystone was another concern.
- Members voted for Glenwood Springs as the meeting site for the 2006 Spring Conference meeting location.

#### **New Business:**

#### **Interactive CCSA Webpage:**

- The employer's relations group brought forward a new proposal they are currently working on. The group is in the beginning stages of writing a grant to help in creating a new webpage for all CCSA member schools to link their webpage's directly to the State of Colorado's employer website to help promote our students as well as our colleges to new employers locating to Colorado. The money from the grant would pay an intern to build an interactive webpage. The intern would be hired from one of the participating member schools and in turn that school would help in hosting the site.
- Members discussed raised and discussed two main questions: 1. Will this include Wyoming as well? 2. Would this be a conflict with the current consortium being developed?
- The employers' group representative stated that the proposal was still in the very beginning stages, but that the group thought it was important to bring to the larger groups attention early. Lisa pointed out that this would need to be voted on through the member list once the employers' relation group was able to provide more detail about their proposal.

President Lisa Severy adjourned the meeting.
